### Making a Difference, Fighting for O&P: AOPA's 2011 Policy Forum

Approximately 100 of your colleagues in the O&P community have signed up to help advocate on behalf of O&P at this year's **AOPA** Policy Forum. And there is still time to join your colleagues and have O&P represented. On April 11 at the L'Enfant Plaza Hotel in Washington D.C., members will be briefed on state and national legislative activities. On April 12 members will have face-to-face meetings with their congressional representatives. Everyone in the O&P field, regardless of specialization has a stake in how the regulations being written by Heath and Human Services (on the essential health benefits package) and Treasury (about the 2.3 percent medical device excise tax) Departments as well as how any new laws affecting healthcare play out in this very uncertain environment.

Your Congressman or Senator will value your input as a constituent and the specific contribution you make as a member of the O&P community to the restoration of mobility and quality of life to your patients. The Forum is designed to help everyone understand the issues and the politics which pose challenges to O&P patient care and equip everyone to have face-to-face conversations with Congressional staff and Members about the Healthcare Fairness Act for Amputees importance to our patients; how our O&P Medicare Improvement Act improves patient care and reduces fraud and abuse; and the need for continued research on comparative cost effectiveness of treatment programs. **AOPA** is scheduling appointments with the Congressional delegations of every attendee's residence and business in order to secure multiple meetings for each attendee. Make sure your legislators hear the case for O&P, too. Register today!

### **Medicare Application Fee**

The new Medicare enrollment regulations went into effect on March 25, 2011. These new regulations included the implementation of a \$505 fee per enrollment and re-enrollment application. Whether you are submitting a traditional paper enrollment application, the CMS 855S form, or enrolling online using the Provider Enrollment, Chain and Ownership System (PECOS), the application fee must be paid using the Department of the Treasury's web based payment system. The application fee must be received before your application can be processed.

To pay the application fees go to <a href="www.pay.gov">www.pay.gov</a> and following these steps:

- 1) On the left hand side of the page you will see a search box called "Find Public Forms". Type "CMS" into the search field and click "GO".
- 2) Select the form for Medicare application fee
- 3) Fill out the form and submit payment as directed (Note: Use MAC ID 99001-NSC)
- 4) Print a copy of the confirmation screen, for your records, this is your receipt of payment

Medicare will forward the payment information to the National Supplier Clearinghouse (NSC), the contractor responsible for processing DMEPOS applications. It is also recommended that you send a copy of your payment receipt to the NSC. If you are enrolling/re-enrolling via paper this receipt can be included with 855S form. If you are enrolling/re-enrolling via PECOS you should also send in a copy of your certification statement.

# U.S. Senate Votes to Repeal 1099 Tax Reporting Requirements from Health Care Reform Law

On April 5, the U.S. Senate voted 87-12 to repeal the "1099 provision" from the Patient Protection and Affordable Care Act. The provision had required business owners to file a 1099 tax reporting document for all vendors from which they purchase at least \$600 in goods or services in a year.

# Representatives in U.S. House Proposed Alterations to Competitive Bidding in Medicare

U.S. House members Jason Altmire (D-PA) and Glen "GT" Thompson (R-PA) together introduced H.R. 1041, the Fairness in Medicare Bidding Act. The bipartisan, deficit neutral bill is designed to ensure that Medicare beneficiaries are allowed to access smaller, more specialized medical equipment suppliers. In the last session of Congress, the bill was proposed and supported by 259 members of the House of Representatives.

### **Phase II PECOS Implementation Remains on Hold**

The Centers for Medicare and Medicaid Services (CMS) recently reported that although a placeholder date of July 5, 2011 has been used for implementation of phase II of PECOS, the actual implementation date remains undetermined at this time.

Phase II of PECOS requires that referring physicians or non-physician practitioners must be enrolled in the Provider Enrollment Chain Ownership System (PECOS) in order for services that they refer to be valid for Medicare claim submission. While CMS has indicated that this will eventually be a requirement for Medicare claims to be processed, they have not published a definitive implementation date.

When an implementation date is announced by CMS, **AOPA** will publish the date right here in the AIA.

### **Network Service Vendor Deadline is Approaching**

If you submit any claims electronically to Medicare, you must migrate to an approved Network Service Vendor (NSV). The NSV will allow for more secure, faster and reliable connections to the Common Electronic Data Interchange (CEDI), the entity that handles all front end processing of DME MAC claims. The migration to an approved NSV must occur before May 1, 2011. After May 1, 2011 if you have not migrated to an approved NSV, you will not be able to send or receive Medicare electronic transactions.

Our objective is to show the successes that people with limb loss or difference can achieve once provided the appropriate tools. Studies have shown that providing O&P services actually saves states money by restoring personal independence and productivity and by reducing secondary and life-threatening complications. Now, we're looking to personalize those findings by telling the stories of those who are living proof.
