## BREAKING NEWS: Dr. Donald Berwick Nominated for CMS Administrator Position

Yesterday, the White House announced President Obama's nomination of Dr. Donald Berwick to be Administrator of the Centers for Medicare and Medicaid Services. Dr. Berwick currently serves as President and CEO of the Institute for Healthcare Improvement and is a professor at Harvard Medical School and the Harvard School of Public Health. Dr. Berwick's other accomplishments include serving on the Institute of Medicine's governing council from 2002-2007 and as the Chair of the National Advisory Council for the Agency for Healthcare Research and Quality.

AOPA will keep members updated in regards to the status of Dr. Berwick's nomination.

## Federal Parity Bill Introduced in U.S. Senate

A correction to the Special Edition AIA sent to members on April 16. Due to a technical problem with the title of the submitted bill, the Federal Prosthetics and Custom Orthotics Parity Act has been issued a new number, S.3223. Despite the new number and revised submission date, the bill maintains its two sponsors, Senators Olympia Snowe (R-ME) and Tom Harkin (D-IA). These same Senators had introduced a prosthetic only bill in the prior Congress championed by the Amputee Coalition of America (ACA).

The text of S.3223 will be posted here as soon as the official version is released.

ACA and **AOPA** have issued a joint press release to media outlets explaining the necessity and the impact of the bill. Click here to read the very persuasive press release sent to media.

ACA and **AOPA**, with important support from the O&P Alliance, have worked hard over the past year to get the bill introduced. Special kudos go to members of the O&P Alliance, each of whom signed on early, and especially to Peter Thomas who did yeoman's work in building the list of other supporting organizations. Lining up to support the legislation in addition to the Alliance members and ACA are 25 other non-profit organizations with a stake in O&P patient care outcomes.

When the American Orthotic & Prosthetic Association (AOPA) developed data demonstrating that the cost per insured of adding orthotics was so insignificant, the ACA and the Senators opted for the more comprehensive O&P parity coverage. ACA and AOPA have partnered on a number of opportunities, including an extensive co-branded advertising campaign, which has advanced the interests of O&P patients.

ACA from the onset has championed very effectively parity efforts at the state level for several years and to date 18 states have enacted some form of parity legislation - some with orthotics and prosthetics covered and some with only prosthetics. Parity bills do not mandate that insurers offer O&P coverage but if the insurer offers coverage, it must be on the same terms with their other medical and surgical benefits in their policy. Without parity insurers could continue penalizing O&P patients with lifetime caps or other coverage limitations.

The importance of Federal parity legislation has grown dramatically with the passage of the recent health care reform law which permits health insurers to sell across state lines under "health insurance compacts." These multi-state arrangements allow the insurer to select the lowest common regulatory denominator. It is feared that states without parity laws would often be the insurer's regulatory venue of first choice. This choice would in effect rescind or override any parity laws that may have been passed in other states served by the "health insurance compact." That makes a Federal parity law virtually indispensable both in filling in the gaps created as to ERISA plans that are unaffected by state laws as well as reinforcing existing state laws most crucial to preserve patient care that is not subject to lifetime limits or other arbitrary benefit caps.

The House version of parity, H.R. 2575, was introduced last year by Rep. Andrews (D-NJ) and Rep. George Miller (D-CA) who is also chair of the Education and Labor Committee.

## As Vital as Ever: 2010 AOPA Policy Forum to be held May 26-27

Discussions at the national level of what should be done about health care have been going on for over a year now, and they aren't done yet. For O&P today there are two critical events taking place on the federal level. First, as a result of health care reform's passage, there are implementation issues that have yet to be resolved in terms of how the law will be applied and how regulations will take shape. Now that the Senate has introduced the Federal Prosthetic and Custom Orthotic Parity bill, both the House and Senate have parity bills ready for passage. Additionally there are challenges on the state level, particularly in regards to licensure, parity and budgets that are vital to the O&P community.

The 2010 AOPA Policy Forum on Wednesday and Thursday, May 26-27, 2010 at the Hyatt Regency

Washington on Capitol Hill looms as even more important with the opportunity for **AOPA** members during their Capitol Hill visits to make a specific "ask" of their legislator for action on O&P issues. At this year's **AOPA** Policy Forum, attendees will be briefed on

- What health care reform will mean to your business;
- How to discuss O&P concerns with members of Congress; and
- Techniques and talking points to take home to their states to further O&P's issues at the state level.

## 2010 Thranhardt Award Winners Announced

The winners of the 2010 Thranhardt Award have been selected in anticipation of the 2010 **AOPA** National Assembly at Rosen Shingle Creek Resort on September 29 through October 2, 2010.

Dr. Andreas Kannenberg's winning entry, "A New Shoulder Orthosis to Treat Painful Shoulder and Facilitate Gait Rehabilitation of Stroke Patients," which is a clinical study with 40 stroke patients

investigating the newly developed shoulder orthosis Omo Neurexa and the extent to which it affects a common issue in rehabilitation of stroke patients: the painful shoulder after stroke (PSS) with or without shoulder subluxation. Dr. Kannenberg is Director of Medical Affairs in Duderstadt Germany for Otto Bock HealthCare GmbH. He has served in that position since 2003. He received his degree in medicine from Humboldt University of Berlin in 1989 and his medical board certification as a general practitioner in 1995. His clinical experience included general and family medicine, surgery, dermatology, internal medicine, rheumatology, orthopedics, and rehabilitation medicine.

The second winner is Dr. Maria Gerschutz, Ph.D. for her paper, "Quantitative Evaluation of Elevated Vacuum Suspension System Effectiveness Under Dynamic Conditions." Dr. Gerschutz's research examined a K3 transfemoral amputee who was measured using a positioning sensor with three prosthetic suspension systems: vented to the air, one-way suction, and elevated vacuum. Dr. Gerschutz is an applied research engineer at Ohio Willow Wood and she earned her Ph.D. in Engineering with an emphasis on biomedical engineering from Wright State University.

Make sure to attend the 2010 **AOPA** National Assembly September 29 through October 2. The Thranhardt Award winners will present their papers on Thursday, September 30 during a special General Session following the address from the Assembly's keynote speaker.

## Update on the California Budget: The Fight for Medi-Cal O&P Reimbursements

The California Orthotics and Prosthetics Association (COPA) has sent an update regarding its opposition to budget recommendations that would cut Medi-Cal O&P reimbursements entirely if \$6 billion of federal funding is not forthcoming. COPA executive director Bryce Docherty testified before the Senate Budget Subcommittee #3: Health and Human Services to oppose the proposed "trigger" elimination of O&P benefits in the Medi-Cal Program. COPA's testimony met with success as the Senate subcommittee voted to reject the proposed cuts that affected O&P. COPA will continue the offensive to make sure O&P reimbursements are not cut from Medi-Cal. Currently there are hearings scheduled for the full Senate Budget Committee and House Assembly Budget Committee at which COPA will testify on behalf of O&P to urge those committees to reject the recommendations as well.
