### Ongoing Need in Haiti for O&P Volunteers

The Haitian earthquake tragedy may not be on front pages anymore or be the lead story on the evening news, but the human need continues. The [joint Web site](#) by AAOP and **AOPA** offers the opportunity for individuals and companies to make known their willingness to help sustain O&P services in Haiti through cash and equipment donations or volunteering of services. The site also gathers needs information such as the following request to AOPA members from Orthopedic Surgeon, Dr. John Lovejoy ([jfl264@me.com](mailto:jfl264@me.com)):

"We are asking a CPO, CP or CO, their spouse and or tech to come for a week or two. The hospital has a residency and room and board. The only expense is transportation and a \$40 gratuity for food and for housekeeping. Ann Cullo is scheduling the trips and has more detailed information. Her email is: [aculloo@aol.com](mailto:aculloo@aol.com). Please pass this on to your members. I would be happy to answer any other questions. John Lovejoy MD"

Here is more background from Dr. Lovejoy on his experience in Haiti: "Dr. Lovejoy has been going to Haiti off and on for 35 years and to the hospital Sacra Couer in Milot for 10 years. He was there after the earthquake and did many amputations. Upon returning he realized the need for a prosthetic lab at their hospital. With the help of Mike Richard, CPO and their community they constructed a lab in a container and shipped it to Milot. They are hoping to staff the facility with volunteers. Their goal is not only to make prostheses but to train Haitians to become prosthetists."

### Update on O&P Reimbursements by Medi-Cal

The March 9 edition of **AOPA in Advance** notified members of potential cuts to reimbursement for O&P by the state of California. Bryce Docherty, Executive Director of the California Orthotics & Prosthetics Association (COPA), spearheaded a charge to oppose a proposed budget policy from Governor Arnold Schwarzenegger that included an option which would eliminate all payments under California Medicaid for the prosthetic and orthotic devices used by amputees and those with other limb impairments starting July 1, 2010.

**AOPA** and the Amputee Coalition of America distributed a press release and provided all support requested by COPA. COPA testified and sent letters to members of the California Senate Budget Subcommittee #3: Health and Human Services and also to the California Assembly Budget Subcommittee on Health and both committees have voted to reject the proposed elimination of reimbursement for O&P services.

COPA's efforts have yielded some positives thus far, but the battle is not over yet. The next important date will be May 14 when Governor Schwarzenegger releases a revised budget cut proposal. Mr. Docherty said that it is uncertain whether the revised budget cut proposal will include any other recommendations to eliminate O&P as a benefit for Medi-Cal patients.

**AOPA** will continue to follow this story and keep members updated.

## Changes to Timely Filing Requirements for Medicare Claims

The Patient Protection and Affordable Care Act (PPACA), signed into law on March 23, 2010 reduces the maximum time period for filing Medicare claims with dates of service on or after January 1, 2010 to one calendar year from the date of service. In addition, the law requires that any claims with a date of services on or after October 1, 2009 but prior to January 1, 2010 must be submitted by December 31, 2010.

Claims with dates of service prior to October 1, 2009 may continue to be filed within the pre PPACA timely filing limits. These limits allow for the remainder of the calendar year from the date of service plus an additional 12 months for claims to be filed with a 10% reduction on assigned claims that are filed more than 12 months from the date of service.

## Updated Information on Signature Requirements

Medicare has recently provided all of its contractors updated information regarding signature requirements for medical review purposes. When contractors (i.e. the DME MACs or the RACs) are reviewing your claims, they may ask for additional information, such as the patients medical records. When reviewing the medical records you submitted they may use the presence or absence of a signature to approve, deny, or seek repayment of your claims.

Any entry that is included in the patient's medical record must be signed and authenticated by the individual who made the entry.

## New York State OIG Reviewing Medicaid Payment for O&P Services in SNFs

The New York State Office of Inspector General has been investigating the improper payment by the Medicaid program of claims for Durable Medical Equipment, Prostheses, and Orthoses provided to patients in a Medicaid covered SNF stay. According to New York State regulations, the Medicaid program payment to the SNF includes these services and therefore they are not eligible for separate reimbursement.

The OIG has examined claims from January 1, 2006 through December 31, 2008 and is in the process of sending overpayment letters to providers whose claims have been identified as paid improperly.

**AOPA** has researched the New York State regulations and it appears that the OIG's investigation is factually accurate.

If you receive an overpayment letter, you may want to review the circumstances surrounding the claim in question and attempt to negotiate payment arrangements with the facility who ordered the original services.

## Results for the March 2010 Business Conditions Survey

The Business Conditions Survey for March 2010 revealed a decrease in the number of firms that reported revenue increases from 2009 to 2010. When comparing that period of time, 47 percent of respondents reported an increase in revenue compared with 62.2 percent who reported an increase in revenue in the February 2010 Business Conditions Survey. In terms of revenue increases, 23.5 percent reported a more than 10 percent increase in revenue; 5.9 percent reported an increase in revenue of 6-10 percent; and 17.6 percent of respondents noted an increase in revenue of 1-5 percent. In terms of decreased revenue, 41.2 percent of firms who took the survey reported a decrease in revenue when comparing 2010 to 2009. Specifically, 23.5 percent reported a decrease of 1-5 percent; 5.9 percent reported a decrease of 6-10 percent; and 11.8 percent reported a decrease in revenue of more than 10 percent. Finally, 11.8 percent of survey respondents reported no change in revenue for March.

Exactly two thirds of respondents reported that their practices have not transitioned to electronic records. Of that group, 46.2 percent believe they will transition to electronic records within the next year. Of the 53.8 percent who do not have plans to transition to electronic records in the next year, some responded that the most significant barrier to entry was a desire for more information and testimonials of electronic transitions.

The survey results presented here represent a compilation of information received from responding member firms. It is not a statistical sample and is for use only as a guide. This would have some impact on survey averages.
