# AOPA Retains Research Consultant

To further advance the O&P research and educational agenda **AOPA** has retained Linchpin Strategies, LLC founded by former Capitol Hill staffer, Catriona Macdonald. Prior to founding her own firm, Ms. Macdonald was vice president of one of the fast track government relations/public relations firms in Washington growing out her experience working for Senator Edward Kennedy on the Senate Labor Committee and staffing social issues and appropriations for the current House Majority Leader, Congressman Steny Hoyer (D-MD). She also was Legislative Director for Congresswoman Rosa DeLauro (D-CT) and worked as a budget and policy analyst in the Office of the Assistant Secretary for Management and Budget at the US Department of Health and Human Services.

Linchpin's O&P agenda will include securing funding for the establishment of five more teaching institutions in the O&P education field in support of NCOPE's 5in5 program and Congressional support for expanded comparative effectiveness research consistent with priorities established by the **AOPA** Board of Directors. The Board's action was in part a response to the National Commission on Orthotic and Prosthetic Education (NCOPE) letter to **AOPA**'s president seeking support for their own efforts to expand the number of teaching institutions.

Tom DiBello, CO, FAAOP, president-elect of **AOPA**, described the Board's decision to retain Linchpin as "another giant step toward bringing O&P out of the research and education dark ages and positioning the field to preserve and expand the ability to continue delivering quality patient care." He added, "Comparative effectiveness research will demonstrate to payers the superior patient outcomes that advanced O&P technology brings to the table. I am convinced that orthotic and prosthetic care is the most cost effective modality in the rehabilitation care continuum and it is incumbent up on us to prove it. These grants will go a long way towards that goal by supporting and expanding the numbers of individuals practicing in the field and by increasing the opportunities for the type of research necessary to validate these positions."

# Proposed FDA Device Rule Open for Comment Until October 4

**AOPA**'s lobbying team at Foley-Hoag has released an internal memo evaluating the Food and Drug Administration's (FDA) preliminary reports regarding actions to improve oversight of medical devices. The reports were prepared by two internal work groups within the FDA's Center for Devices and Rediological Health (CDRH) working on measures to (1) foster medical device innovation; (2) enhance regulatory predictability; and (3) improve patient safety. The findings of the groups are open for comment until October 4, 2010.

# O&P INSIDER'S TRACK The Only Up-to-the Minute O&P Newsline In Memoriam

**Todd Anderson**, of Otto Bock HealthCare, passed away August 18, 2010. Otto Bock released a statement mourning the loss of Mr. Anderson:

We will miss him and his ability to open doors, lighten lives, and to spark a smile and a laugh. Todd Anderson was born in 1960 and spent his years in motion. Whatever role he played, he was fully engaged, taking on new challenges, reaching for new adventures and experiences, and often leaving those he touched changed for good.

From an early age his path encompassed sports of every variety, and he enjoyed nature as a sportsman, adventurer and photographer. Most of all, he had a great passion for his family and all those he cared for. His achievements included being an eight-time National Tournament Most Valuable Player and Hall of Fame Inductee for the National Wheelchair Softball Association, a record holder in the 200 meter run World Record in Gothenburg, Sweden, and membership in the United States Disabled Volleyball team from 1993-1994, and multiple awards for archery. He always pushed himself to improve, to go from good to great, and to help others enjoy and explore new activities.

Todd's education included a Bachelor of Science from the University of Wisconsin, a 1984 post-graduate certificate in Clinical Education from White Bear Lake, and in 1986 was certified as a Prosthetist by the American Board for Certification in Orthotics and Prosthetics. He was one of the first clinicians to be recognized as an Academy Fellow (FAAOP) in 2001, a reflection of his commitment to learning. He authored many respected clinical works, and presented to countless audiences.

Todd's career started in 1985 at Northwestern Artificial Limb and Brace in Minneapolis, MN. In 1989, he worked at Green Bay Orthopedic Company in Green Bay, Wisconsin. Next, he worked as the Clinical Manager at the Shriners Hospital for Children in Minneapolis, Minnesota. He came to Otto Bock on August 16, 1999 as the Director of Professional and Clinical Services. He spent the intervening years building a Professional and Clinical Services team that delivers more than 400 educational opportunities annually. At Otto Bock, he most recently opened the Innovation Center and launched the concept of Cooperative Care. His unerring compass kept everyone around him focused on improving care and outcomes for people with limb loss and other physical challenges. As Todd himself said, he works for people with limb loss and other disabilities - he just happens to do that work at Otto Bock.

Todd also advanced the industry in other ways, including four years as a board member for the United States International Society of Prosthetists and Orthotists (ISPO), a President of the Minnesota Chapter of the American Academy of Orthotists and Prosthetists, and most recently served as the Secretary-Treasurer of the American Board for Certification in Orthotics, Prosthetics and Pedorthics.

Mr. Anderson's family has asked that any memorials be given to the following organizations in Mr. Anderson's memory: <a href="Shriners Hospital">Shriners Hospital</a>, <a href="Courage Center">Courage Center</a>, and/or the <a href="Amputee Coalition of America">Amputee Coalition of America</a>.
