The AOPA Policy Forum an Important Success for 2011: Rigorous Information from Experts, Effective Advocacy from Members!

Last week's 2011 Policy Forum from **AOPA** proved to be a success for **AOPA** members and the O&P community as a whole. The first day provided attendees intensive information sessions about the condition and trajectory of O&P amid a very challenging political environment. More than 100 **AOPA** members attended the sessions which focused on legislative and regulatory issues on both the state and national level.

Reflecting the growing importance of state level issues now moving to center stage, a special training session was held for those **AOPA** members who have volunteered to be **AOPA**'s eyes and ears in the states by watching for any regulatory or legislative threats to O&P. The "state reps" are the early warning system because so many issues begin in one state and quickly ricochet to all 50. To further strengthen the ability to deal with state issues, **AOPA**'s Policy Forum enlisted Denise Rozell, assistant vice president, state government relations at Easter Seals. She described the mechanics of their state advocacy effort at the training session for **AOPA** members volunteering to be state reps that kicked off the Policy Forum activities. Easter Seals could be a possible role model for the O&P community. At a later session Mary Andrus, assistant vice president, government relations at Easter Seals told how state and federal issues intersected in their own advocacy efforts to provide a much stronger program at both levels. Both emphasized the importance of face-to-face advocacy and the need to enlist patients and other organizations with common interests as co-advocates.

Other sessions with an emphasis on national legislative and regulatory issues included a tutorial by two former Congressmen, Scott Klug (R-WI) and Earl Pomeroy (D-ND) on current and future budget deliberations and their potential impact on O&P. Mr. Laurence Wilson, Director, Chronic Care Policy Group, provided the CMS address answering a range of questions. Several speakers briefed attendees on our Medicare and insurance legislation.

Chair of the Health Subcommittee of the House Ways and Means Committee, Rep Wally Herger (R-CA) concluded the session with a hard hitting message on reining in government spending but made a special point of singling out the great contribution made by O&P. Thirty-one **AOPA** members participated in a separate O&P PAC reception that evening for Congressman Herger further cementing a very important relationship to the O&P community.

On day two, Tuesday April 12, **AOPA** members attended a record number of visits on the Hill: more than 100 **AOPA** members each attending 2-8 meetings for a grand total of 413 meetings with Members of Congress and staff for the 2011 Policy Forum. These annual visits make a huge contribution toward expanding the understanding and appreciation for the unique difference O&P services make in the lives of patients. Members drove home the message that what they do is often the touchstone to achieving a quality of life that returns each patient to their maximum potential. Last year's Policy Forum achieved 232 separate meetings with the legislative decision makers. During the visits, **AOPA** members were given a set of talking points to use along with their anecdotal experiences as patient care providers and made "asks" of the offices for support on specific issues. The talking points included:

- O&P Medicare Improvement Act: Main message Saves taxpayers a minimum of \$250 million over five years by curbing fraud and abuse. Key components: (1) Reimbursing in licensure states only those properly licensed. In non-licensure states reimbursement is limited to only those credentialed by a recognized body that meets ABC or BOC standards.
   (2) It limits deemed accrediting bodies to those experienced in O&P that meet BIPA 427 criteria. (3) Links reimbursement to the qualifications of the provider and the complexity of the device the patient needs.
- Insurance Fairness for Amputees Act (S.773): Main message Providing timely O&P treatment can avoid costly co-morbidities and return patients to active, productive lives as taxpayers instead of consumers of tax dollars. This legislation was previously known as "O&P Parity" but many misunderstood this as a mandate for coverage. The bill name was changed to make clearer that only if a private insurer chooses to offer O&P coverage it must provide it at the same surgical and medical benefits of other covered risks with no caps or lifetime limits. Studies show that the incremental costs of this coverage improvement would cost less than 60 cents, in additional premium per insured, per year.
- Inclusion of Orthotics and Prosthetics in Definition of "Essential Benefits": Main message it was always intended that O&P be included as was clearly stated in the House version of the Affordable Care Act. However, the Senate version was signed into law and left defining essential benefits to the Secretary of Health & Human Services. Rep. George Miller (D-7<sup>th</sup> CA) and Rep. Bill Pascrell, Jr., (D-8<sup>th</sup> NJ) have issued statements in the Congressional Record confirming this intent. Not being included could seriously affect O&P patient care with third party payers all over the lot in providing coverage.
- Exclude O&P Medical Devices from 2.3 Percent Excise Tax: Main Message O&P providers deliver a finished device at their facilities to patients for their individual use, and therefore should qualify for one of the exemptions from the tax set out in the law. FDA rules over the past 35 years have referred to retail O&P patient care facilities. Eyeglasses and hearing aids are exempt as prescribed custom modified articles which match in many ways

- the process of O&P provided care. **AOPA** believes both manufacturers and patient care facilities qualify for the exemption.
- Support Veterans Bill of Rights (HR 805): Main Message Make sure veterans know their current right to obtain treatment from a practitioner of their choice in a venue of their choice. The bill requires these rights to be posted in every VA O&P clinic for injured and amputee veterans to see. It promotes a continuum of care for amputees transitioning from the Department of Defense (DoD) to the Department of Veterans Affairs (VA).
- O&P Needs Short Term Grants to Train Future Practitioners: Main message the
  aging population and increasing incidence of diabetes and other cardiovascular disease
  creates growing demand for highly skilled practitioners to provide O&P services. As entry
  level qualifications requiring a master's degree, the shortage of skilled professionals will
  skyrocket as more and more current practitioners retire. These grants are needed to meet
  this critical demand.
- Funds should be provided for Outcomes-Based Research/Evidence-Based Practice: Main message while Congress has provided research funds to restore maximum functionality for wounded warriors and veterans, O&P research has been less focused on outcomes than in research by allied health professions. Significant research questions remain unanswered such as: (1) What interventions can prevent amputation or subsequent surgeries; (2) at what point in treatment is O&P intervention most effective; (3) which patients benefit most from which technologies; (4) what O&P practices facilitate successful aging, and how does the aging process affect the use of prosthetics, including skin breakdown, loss of balance, falls and other issues, such as promoting return to work? These and other key questions remain unanswered but outcomes research can be vitally important in reducing future health care costs and ensuring that patients receive appropriate, necessary care.

2011 will be a challenging year and a year that will demand intense vigilance and action to make sure that O&P patients are protected. **AOPA** will continue to work with members who face challenges on the state level and will continue to lead the charge in DC on several legislative and regulatory fronts. **AOPA** will keep members apprised of all these activities and we hope you will join us next year at the 2012 Policy Forum.

The Amputee Coalition and AOPA Hail Senators Snowe (R-ME) and Harkin (D-IA) for Introducing S.773, the "Insurance Fairness for Amputees Act" in U.S. Senate

On April 8, Senators Olympia Snowe (R-ME) and Tom Harkin (D-IA) introduced S.773, the Insurance Fairness for Amputees Act. These same two Senators had introduced the orthotic prosthetic parity bill in 2008 and again in 2010. In its prior incarnation in 2010, the bill had been called the Senate Prosthetics and Custom Orthotics Parity Act.

The Amputee Coalition and **AOPA**, with important support from the O&P Alliance have worked hard to

get the bill introduced in the 112th Congress. **AOPA** has developed significant data to demonstrate that the costs of extending this bill to include orthotics as well as prosthetics would not undermine the bill's prospects for being enacted. In the course of this effort, an excellent strategic and working partnership has been forged between **AOPA** and the Amputee Coalition, which has, from the outset, championed so effectively the effort to enact parity statutes at both state and federal levels.

And the Fairness for Amputees Act is more important than ever. Under the health care reform law signed in 2010, the *Patient Protection and Affordable Care Act (PPACA)*, there are provisions for sale of health insurance across state lines using health insurance compacts.

S.773 is not a mandate for coverage, but it does say that any insurer which offers orthotics and/or prosthetics coverage is required to provide it on the same terms as that policy's general medical and surgical provisions. This means there could be no lower lifetime caps, no "one prosthesis/orthosis per life" provisions.

So, with the introduction of S.773, we now have prosthetic and orthotic parity bill in the Senate and anticipate the same bill being introduced soon in the House or Representatives in the near future. In the meantime, **AOPA** thanks Senators Snowe, Harkin and their staffs for their hard work and for introducing S.773, the Insurance Fairness for Amputees Act.

### HIPAA 5010: CEDI Educational Calls

Beginning January 1, 2012, all HIPAA covered entities (suppliers, health plans, clearinghouses, billing services, etc.) will be required to use the new HIPAA 5010 format for all HIPAA covered electronic transactions (claims submissions, remittance notices, claim status requests, etc.). If you do not make the switch to the HIPAA 5010 format before January 1, 2012, you will experience delays in processing your claims with both Medicare and private payers, as the current 4010 format will not be accepted after January 1, 2012. Don't wait or hesitate, the deadline is closer than you think.

The Common Electronic Data Interchange (CEDI) will be offering a series of educational calls to help Medicare Fee for Service Providers make the switch to the new HIPAA 5010 format. The first call will take place on April 27, 2011 at 1:00 pm EDT. This first call will provide you with an overview of the 5010 transition and what you need to do to get ready for the transition.

The patient should possess the following traits/characteristics:

- 1. Articulate and outgoing
- 2. Happy/positive
- 3. Thriving with prosthetic or custom orthotic device that was paid for in part by Medicaid coverage
- 4. Preferably maintains a full or part-time job
- 5. Willing and comfortable with sharing personal details of their story and the impact of being an amputee
- 6. Has a well-maintained physical appearance
- 7. Over age 21
- 8. Has given you permission to send us his/her story and contact information

The patient should NOT possess the following traits/characteristics:

- 1. Quiet, gives one word responses to questions
- 2. Sarcastic, cynical, or negative
- 3. Curses frequently
- 4. Openly and irrationally critical of others, including government organizations or a previous care provider

Our objective is to show the successes that people with limb loss or difference can achieve once provided the appropriate tools. Studies have shown that providing O&P services actually saves states money by restoring personal independence and productivity and by reducing secondary and life-threatening complications. Now, we're looking to personalize those findings by telling the stories of those who are living proof.
