VA Meeting Follow-Up Seeks Clarification on Treatment Choices

AOPA representatives met on May 25, just prior to the 2010 **AOPA** Policy Forum, with Department of Veterans Affairs officials led by Billie Jane Randolph, Ph.D., PT, OCS, Deputy Chief Consultant of Prosthetic and Sensory Aids and sought to clarify concerns that private practitioners were not securing opportunities for veterans to choose their services over VA delivered services. Deputy Randolph reaffirmed that VA does indeed offer the option to veterans to choose where and from whom they wish to receive care - whether from VA personnel and clinics or from contracted "partners."

AOPA President James A. Kaiser, CP, Treasurer Jim Weber, MA, Executive Director Tom Fise, JD and Kathy Dodson, Senior Director of Government Affairs represented **AOPA** at the meeting and raised the issue of how do veterans know about their choices if the "partners" aren't there in person. They also related the concerns expressed by a few members that the VA has a short or long-term plan to have "inside" government personnel offered as any sort of option for Medicare, in addition to the VA personnel. Dr. Randolph reassured the group there was not any substantial or imminent move to make these kinds of changes.

In a follow up letter to Dr. Randolph, **AOPA** reported that several **AOPA** members attending the **AOPA** Policy Forum took exception with the VA assurances and simply said, "it just ain't so." They reported their own experiences in Alabama and Florida where VA facilities most frequently first tell veterans they must receive their care from VA employee-practitioners in the VA facility. **AOPA** recommendations to deal with this issue are detailed in a letter sent Dr. Randolph on July 25.

Sadly, the request for the meeting was confirmed by VA with an only 48 hour advance notice making it impossible for any members of **AOPA**'s Veterans Affairs Committee to alter travel plans permitting them to attend the meeting.

Thanks go to **AOPA** Board Member, Frank Vero, CPO, who first alerted **AOPA** to the current "choice" problem and which triggered **AOPA**'s request for the meeting.

BREAKING NEWS: Orthotics May Be Exempt in Round Two of Competitive Bidding

It appears from preliminary sources that off-the-shelf orthotics have once again dodged the bullet on competitive bidding. In an as yet unpublished Federal Register notice, CMS says that OTC orthotics

will continue to be exempt from competitive bidding for physicians and "other practitioners" who provide such services directly to their own patients. Currently, CMS has interpreted "other practitioners" to include O&P practitioners. However, until this notice is officially published in the Federal Register, it is not a certainty. Stay tuned for further updates.

New Diabetic Shoe Documentation Requirements Effective July 1, 2010

The four DME MAC Jurisdictions have announced new documentation criteria for the provision of therapeutic shoes. When providing therapeutic shoes, inserts, or modifications, you must now document an in-person evaluation of the patient prior to them selecting shoes, and you must conduct an in-person evaluation at the time of delivery.

The in-person evaluation prior to services being provided should include an examination of the patient's feet and a description of any conditions that will be treated by the shoes, inserts, or modifications. During this evaluation, you should document any measurements you made of the patient's feet and any casts or impressions you may have made.

When conducting the in-person delivery, you must document that the shoes and/or inserts fit the patient properly and are meeting the patient's needs.

The documentation of these in person evaluations does not need to be submitted with your claims, but they must be made available upon request. If these documentation requirements are not met, the claims will be denied as statutorily noncovered.

The new documentation criteria will be effective for claims with a date of service on or after July 1, 2010, and will be included in a future revision of the Therapeutic Shoe policy.

Final PECOS Reminder - July 6, 2010 Implementation Date Confirmed

AOPA has confirmed that the implementation date for PECOS enforcement has been changed to July 6, 2010. **AOPA** staff spoke with James Bossenmeyer, the CMS official responsible for PECOS implementation. Mr. Bossenmeyer confirmed his previous statement that provisions of the Patient Protection and Affordable Care Act (PPACA) require PECOS requirements to be effective July 6, 2010.

As previously reported claims received on or after July 6, 2010 that are the result of a referral from a physician without a current PECOS enrollment file are eligible to be rejected. While CMS has admitted that system edits may not be fully functional by this date and therefore claims resulting from ineligible referrals may be paid, it has reiterated that once the system edits are in place, the DME MACs may reprocess these claims, resulting in overpayment requests.

CMS has instructed its contractors, including the DME MACs, to send a letter to physicians in their systems that do not have a current PECOS record. The purpose of the letter, which is supposed to be sent by June 28, will be to provide instructions to physicians regarding how to enroll in PECOS as well as reminding them of their obligation to do so. CMS has published Medlearn Matters Article MM6842 which notifies the provider community that the letter will be sent.

"Doc Fix" Extended until November 30: CMS Reimbursement Levels Maintained

The 21.3 percent, across-the-board rate cut to Medicare reimbursements was delayed once again from being implemented. On Friday, June 25, 2010, President Obama signed the Preservation of Access for Medicare Beneficiaries and Pension Relief Act of 2010 into law. This bill, a 6 month extension of reimbursement payment rates informally referred to as the "Doc Fix," instead of slashing payments by 21.3 percent actually increases reimbursement payments by 2.2 percent through November 30, 2010. The previous doc fix extension expired earlier this month on June 1.

Even though **AOPA** welcomes this law, **AOPA** is concerned about the fact that Congress has kicked the can down the road once more on this important issue. After having failed in an attempt to include the doc fix in the health care reform bill, abandoning earlier this year a stand-alone bill that contained a permanent fix, this extension of Medicare payments will likely result in Congress having to meet for a lame duck session to debate and extend benefits to providers once more in 2010. As this issue drags out **AOPA** believes that the likelihood of deeper cuts to services increases as there will be more and more debate about levels of health care spending. At this moment, though, the June 25 doc fix has preserved physician reimbursements until November 30. **AOPA** will continue to monitor the situation and keep members apprised of how this issue continues to develop.

May 2010 Business Conditions Survey Results

The Business Conditions Survey for May 2010 revealed deterioration in the revenue picture for survey participants. 44.4 percent of respondents reported a May 2009-to-May 2010 increase in revenue compared with 46.7 percent in April. 22.2 percent of respondents had increases of more than 10 percent and that same number saw an increase in revenues of 1-5 percent. The largest segment of participants, 33.3 percent, reported a 1-5 percent decrease in revenue; and 5.6 percent of respondents reported their businesses having a decrease in revenue of more than 10 percent. Finally for May, 16.7 percent of survey participants reported no change in revenue.

Survey respondents linked the decrease in revenue to several factors including regional unemployment affecting payment; a general increase in bad debt write offs; an increase in Medicaid patients and the corresponding reimbursement differences between Medicaid and other third-party payers; and more patients not being able to meet the co-pay requirements of their insurance provider.

Finally, awareness of the new PECOS implementation date was high among respondents, with only 5.6 percent reported being unaware of the July 6 implementation. When asked about the estimated percentage of the referring physicians with whom they do business, survey participants consistently indicated that between 75 to 95 percent of referring physicians were already in PECOS.

The survey results presented here represent a compilation of information received from responding member firms. It is not a statistical sample and is for use only as a guide. Information is also presented from prior surveys for comparative purposes. It is important to remember that there may be a different mix of firms responding in each survey. This would have some impact on survey averages.
